**Plan A: One payment.** This payment is due August 1 Payable by Cash, Cheque or e-transfer.

**Plan B: Two payments.** The first payment (60% of tuition) is due August, and the second payment (40% of tuition) is due the following January. (Not applicable for students starting mid-year.) Payable only by Pre-Authorized Debit

**Plan C: ELEVEN payments.** First payment starting August, the eleventh payment is due the following June. Includes additional 2% service charge for Plan C. Payable only by Pre-Authorized Debit

### NEW STUDENT FEES:

**Registration Fee:** \$ 200

**Enrollment Deposit:** (non-refundable & applied to tuition) \$ 500

### CONTINUING STUDENT FEES:

**Re- Enrollment Fee:** (yearly) \$ 100

**Late Payment Fee:** (per month on all balances due over 30 days) \$ 25

**Insufficient Funds Fee:** \$ 25

All tuition for the year must be arranged upon enrollment

**Sibling Discounts**

We recognize the impact that the cost of a Montessori school education can have on families with multiple children. To assist families considering Meadow Montessori, we have established a tuition discount for families with multiple siblings.

<b><i>Second child enrolled</i></b>	<b><i>5% discount on full tuition</i></b>
<b><i>Third child enrolled</i></b>	<b><i>8% discount on full tuition</i></b>
<b><i>Fourth &amp; subsequent child enrolled</i></b>	<b><i>10% discount on full tuition</i></b>

Grace period: The school provides a grace period of four calendar days after the stated due date.

Tuition payments in arrears for more than ninety (90) days may result in a student’s suspension from classes and/or withholding of student records.

Meadow Montessori School Society reserves the right to withdraw students from the program at any time if any tuition remains outstanding.

Parents who receive subsidy are responsible for paying their portion of the fees and ensuring their child’s fees and subsidy documentation is current.

Good financial standing: All tuition and fees must be arranged prior to the start of the school year to be considered in good financial standing. Good financial standing is required for a child to start a new school year or for school records to be released to other schools.

Continuing/Re-enrollment: The re-enrollment fee must accompany the re-enrollment contract. A contract will not be accepted until payment is made. January 31 is the deadline to retain placement.

Receipts/Statements: Please submit your request in writing—specifying exactly what information should be included. The Office will prepare these statements once a month so please consider this when timing your request.

*The school understands that families may experience financial difficulties and we are committed to working with families to make arrangements for payment. Please contact the Director/Principal with regards to financial issues.*
